In reference to: Opinion regarding the protection of historical monuments for the following investment:  
extension of Ślężoujście Street within from Rędzińska Street to Potokowa Street in Wrocław (as presented in the  
land development plan attached to the application).

In response to your letter, ref. file no. 70/P/2019/DJ, dated 22.02.2019, received on 22.02.2019, in the  
matter as specified above, I would like to inform you that the planned investment is located in the area of  
intensive prehistoric, medieval and modern settlement, within the impact of the archaeological site no. 10/9/79-  
28 AZP (settlement of the Przeworsk culture population, a trace of settlement of the Lusatian culture, a trace of  
prehistory settlement, a trace of late-medieval settlement). This area is treated as a monument pursuant to Article  
3 Item 4, 12 in connection with Article 6 Clause 1 Item 3 of the Act dated 23 July 2003 on the protection and  
care of historical monuments (i.e. Journal of Laws of 2018, item 2069, as amended) and is included in the list  
referred to in Article 7 of the Act dated 18 March 2010 amending the Act on the protection and care of historical  
monuments and amending certain other acts (Journal of Laws No. 75 of 2010, item 474).  
For the project covered by the submitted design documentation, prepared by Dorota Wolińska-Janosz, M.Sc.,  
Eng. the following conservational conditions apply:

- it is required to conduct rescue archaeological research studies in line with the permission of the Lower Silesian  
Provincial Conservator of Monuments, in line with the procedure provided for in Article 36 Clause 1 Item 5 of  
the Act dated 23 July 2003 on the protection and care of monuments (i.e. Journal of Laws of 2017, item 2187 as  
amended) and the Regulation of the Minister of Culture and National Heritage dated 2 August 2018 on the  
conduct of conservation works, restoration works and conservation research on monuments entered in the  
register of monuments or on the List of Heritage Treasures, as well as construction works, architectural research  
and other operations on monuments entered in the register of monuments, and archaeological research and  
search for monuments (Journal of Laws of 2018, item 1609).

The insertion of the above conditions in the decision on the implementation of the road investment, on the  
grounds of the principle specified in Article 11 f. Clause 1, Item 3 of the Act dated 10 April 2003 on the special  
principles of preparation and implementation of investments in the scope of public roads is necessary for the  
permanent preservation of the monument and its value, in line with Article 4 of the aforementioned Act on the  
protection and care of monuments dated 23 July 2003.
