

## Invitation for Bids without Prequalification (IFB)

1. This Invitation for Bids (IFB) follows the General Procurement Notice (GPN) for this project that appeared in UNDB online on 23.07.2015.
2. The Republic of Poland has received a loan from the International Bank for Reconstruction and Development (IBRD) for the costs of the Odra-Vistula Flood Management Project and intends to use a portion of the proceeds of this loan for payments related to the **Contract: 2B.2/2(a) "Flood protection of cities along Bystrzyca Dusznicka river: Polanica-Zdrój, Szczytna river Kamienny Potok"**.  
The project will be co-financed from the loan of the Council of Europe Development Bank (CEB) and the state budget.
3. **State Water Holding Polish Waters Regional Water Management Authority in Wrocław** serves as the implementing agency for the project and invites sealed bids from eligible Bidders for the execution of the Contract described below.

### Task description:

- a) **Task No. 1: "Implementation of works related to the reconstruction of facilities on the Bystrzyca Dusznicka River in the area of Polanica-Zdrój" including the modernisation of flood protection equipment and engineering infrastructure, including:**
  - a. Trees and bushes cutting and protection,
  - b. Construction site preparation and demolition works,
  - c. Construction of a Class IV flood embankment at km 12+455 ÷ 12+562 of the Bystrzyca Dusznicka rivers,
  - d. Construction embankment culvert and demolition and construction of a ditch,
  - e. Construction regulatory wall at km 15+053 - 15+085,
  - f. Superstructure of walls and reinforced slopes,
  - g. Renovation of existing walls and reinforced slopes,
  - h. Set-off construction,

- i. Renovation of riverbed revetments,
  - j. Construction of the debris flow dam,
    - earthworks,
    - directing walls,
    - buttresses, foundation and pillars of the dam as well upstream and downstream apron slabs, revetment of slopes,
    - superstructure of walls,
    - prefabricated retaining walls,
    - road reconstruction,
  - k. Conversion of H-23 sill with the construction of the swift current and other works,
  - l. Greenery and other works,
  - m. Reconstruction of external sewage and drainage systems,
  - n. Disassembly of inactive gas networks,
  - o. Reconstruction of site lighting and protection of the MV cable line,
  - p. Reconstruction of telecommunications networks.
- b) Task No. 2 "Renovation of works related to the reconstruction of facilities on the Kamienny Potok stream in the area of Szczytna" including the modernisation of flood protection equipment and engineering infrastructure, including:
- a. Trees and bushes cutting and protection,
  - b. Construction site preparation and demolition works,
  - c. Construction of riverbed revetments TYPE I - regulatory walls,
  - d. Reconstruction of riverbed revetments TYPE II - reconstruction of existing walls,
  - e. Execution of riverbed revetments TYPE III - stone rip-rap,
  - f. Reconstruction of riverbed revetments TYPE IV – set-off reconstruction,
  - g. Reconstruction of riverbed revetments TYPE V - reconstruction of bank revetments,
  - h. Conversion of weirs and sills into riffles,
  - i. Other facilities,
  - j. Greenery and other works,
  - k. Reconstruction of external sewage and drainage systems,
  - l. Disassembly of inactive gas networks,
  - m. Reconstruction of telecommunications networks:

- dismantling,
- overhead telecommunications line.

4. The bidding will be conducted as the International Competitive Bidding (ICB) specified in the World Bank Procurement Guidelines: Procurement of Goods, Works and Non-Consulting Services under IBRD Loans and IDA Credits & Grants by World Bank Borrowers], issued in 2011, amended in July 2014. [*Guidelines: Procurement of Goods, Works and Non-Consulting Services under IBRD Loans and IDA Credits & Grants by World Bank Borrowers*], issued in 2011, amended in July 2014. („Instrukcja Banku Światowego dotycząca zamówień”) and it is open for all the bidders who qualify in accordance with the definition included in the said “World Bank Procurement Guidelines”, who meet the minimum qualification criteria.

Bids will be opened in the presence of Bidders' representatives who choose to attend at the address below (point 8) on **16.03.2023 at 10:05 a.m.**

In connection with the existing epidemic threat / epidemic status, the Employer may make a decision in advance of the opening of the bids only via online transmission (at least 7 days).

All bids must be accompanied by a bid security for the amount of **PLN 500 000,00 (in words: five hundred thousand zlotys 00/100)**
