Expansion of the existing embankments of the river Odra at 26+000÷33+250 km -Reinforcement of the existing flood embankments applies to the section at 26+000÷32+700 km, which corresponds with 582.5÷588.0 km of the Odra river watercourse and 185 m of the side embankment. The scope of the works, among others : a) Geodetic works b) Removal of vegetation c) Removal of humus d) Demolition of building structures e) Design of the embankment: Reinforcement of the existing embankment consists in setting the leak-tight wall made of piling sections GU 7S and GU 20N on its upstream face, crowned with the reinforced concrete pile cap. The complete length of the wall: 6,774 m. Two sections have been excluded along the embankment: the first near the bridge across the Odra river (between 30+168 km and 30+233 km of the embankment), the second at the crossing of the embankment with the road to the RZGW Szczecin watermaster's house (between 30+772 km and 30+818 km of the embankment). In the areas of the existing underground utilities, the steel wall will be left out, and the embankment will be sealed with jet-grouting. f) Drainage g) Sowing the slopes and the crown with grass mixture

- i) Construction of new slope stairs in the place of the existing ones

2. Construction of the ring embankment

The beginning of the new section of the embankment is in the area of 587.4 km of the Odra watercourse, i.e. in the area of 26+563 km of the Odra embankments. The route of the ring embankment is running from the place of contact with the Odra embankments, north to the existing building development, to the national road no. 31 Słubice-Kostrzyn, and farther on along this road to the edge of the Odra valley upland near Drzecin. The total length of the embankment is 5.9 km.

The scope of the works, among others :

- a) Geodetic works
- b) Removal of vegetation
- c) Removal of humus and weak soil
- d) Demolition of the existing building structures
- e) Anti-filtration barrier
- f) The body of the embankment
- g) Reinforcement of the slopes and crown of the embankment
- h) The embankment culverts on the designed ring embankment
- i) The passages across the ring embankment
- j) The road culverts

3. Rebuilding Czarny Kanał and Racza Struga

Rebuilding the streams applies to the river bed of Racza Struga along the section of 2,000 m and the Czarny Kanał river bed along the section of 4,065 m.

The regulation works will be conducted in the sections:

a) Czarny Kanał from 4+612 km to 8+677 km

Rebuilding the Czarny Kanał river bed will be executed along the section of 4,065 m in three sections: the southern section (Pd), 2,936.00 m long, above the designed culvert under the ring embankment, the central section, 59.30 m long, including the embankment culvert with the reinforced sections of the river bed, the northern section (Pn), 1,069.70 m below the embankment culvert.

The scope of the works applies to the southern and northern sections of the channel (the central section is included in the scope of construction of a new ring embankment).

b) Racza Struga from 27+158 km to 29+158 km

Rebuilding the Racza Struga river bed will be executed along the section of 2,000 m in three sections: the southern section (Pd), 1,169.00 m long, above the designed culvert under the ring embankment, the central section, 83.20 m long, including the embankment culvert with the reinforced sections of the river bed, the northern section (Pn), 747.80 m long, below the embankment culvert.

The scope of the works applies to the southern and northern sections of the channel (the central section is included in the scope of construction of a new ring embankment).

The sections of the channels running under the embankment of the ring embankment have been excluded from the scope of the regulation works, as their rebuilding (the culverts and the reinforcement of the inlets and outlets) is included in the scope of construction of the embankment.

The detailed description of the Works is included in the Building Design documents and in the relevant Executive Designs.
