The Republic of Poland has received a loan from the International Bank for Reconstruction and Development (IBRD) for the costs of the Odra-Vistula Flood Management Project and intends to use a portion of the proceeds of this loan for payments related to the Contract: **1B.8: Flood protection of Krosno Odrzańskie.** The project will be co-financed from the loan of the Council of Europe Development Bank (CEB) and the state budget.

State Water Holding Polish Waters Regional Water Management Authority in Wrocław now invites sealed bids from eligible bidders for the realization of the Project described below.

Description of the Contract:

The subject of the contract is the execution of Works related to the execution of the project entitled: **Contract No. 1B.8** '' **Flood protection of Krosno Odrzańskie**'' including:

1. The construction of flood embankments covering the total length of approx. L=5892,0m

2. The performance of the reconstruction, development and construction of Bypass Channels covering the total length of approx. L = 2536.0 m

The planned investment includes the construction of 9 sections of embankments, from the side of the Odra River or its canals, along with the implementation of anti-erosion protection on their slopes. The objects of the existing flood protection system and the planned flood embankments were included in the second class of importance of the main hydrotechnical constructions

The detailed description of the Works is included in the Building Design documents and in the relevant Executive Designs.

Investment location:

The investment is located in the Odra River Valley, in the section from km 513.5 to km 514.70 within Krosno Odrzańskie City in Krosno Odrzańskie Commune,
