The project will be co-financed by the credit from Council of Europe Development Bank (CEB) and national budget. Bidding process will be governed by the World Bank's rules and procedures.

The main task covered by the Contract includes construction of telecommunication and network connections between Operational Centres and hydrotechnical facilities.
