II.1 .4) Short description:

The Republic of Poland has received financing from the World Bank toward the cost of the Odra Vistula Flood Management Project, and intends to apply part of the funds from the load is intended for the Contract-related payments - 4B.1/4 Operational Centers in Krakow and Wroclaw - Digital dispatching communication system for hydrotechnical facilities. The project will be cofinanced by the credit from Council of Europe Development Bank (CEB) and national budget. Bidding process will be governed by the World Bank's rules and procedures.

The main task covered by the Contract includes construction of telecommunication and network connections between Operational Centres and hydrotechnical facilities.

Bidding was conducted through the International Competitive Bidding procedures as specified in the World Bank's Guidelines: Procurement of goods, works, and non-consulting services under IBRD loans and IDA credits & grants", [Guidelines: Procurement of Goods, Works and Non-Consulting Services under IBRD Loans and IDA Credits & Grants by World Bank Borrowers], issued in January 2011, amended in July 2014 ("The World Bank Guidelines") and it is open for all bidders who qualify, as defined in the World Bank Procurement Guidelines.

The main task covered by the Contract includes construction of telecommunication and network connections between Operational Centres and hydrotechnical facilities.

The project will cover the area of the Lower and Middle Odra River and the Upper Vistula River basins. Barrages, reservoirs and other hydrotechnical facilities are located on the area.

The basic task of data transmission links will be the transmission of telemetric data and transmission of video signals (CCTV). Additionally, the link can be used in the facilities by the facility staff as access to the public network.

Hydrotechnical facilities can be divided into two groups in terms of bandwidth requirements:

Network facilities with permanent service of primary importance:

- basic link: fibre optic or radio link, symmetrical transmission min. 40/40Mbps
- backup link: GSM/LTE modem, transmission min. 20Mbps with a data limit of min. 40GB per month, or globally, as a dedicated APN.

Network facilities without permanent service:

• 2 GSM/LTE modems, transmission min. 20Mbps with a data transmission packet of min. 20GB per month for each SIM card or globally as dedicated APNs.

The Network facilities are located in the vicinity of the towns where the data transmission networks of telecommunication operators are located. Considering the expected lengths and assumed parameters of basic links, it was assumed that fibre optic links will be built to the mentioned facilities. It is possible to build a radio link.

The Internet access service will be launched based on the optical fibre connections or radio lines built. The service will connect all locations into one network, replacing the current Internet connections. It will enable the communication of all ICT systems currently used based on Internet links and the designed DMR crisis communication system.
