NOTICE TO SKIPPERS No. 56/2021

Re.: The opening of the Downtown Water Junction in Wrocław

Pursuant to Art. 14 sec. 1(4) of the Act of 20 July 2017 – Water Law (Dz. U. /Journal of Laws/ of 2020, item 310, 284, 695, 782, 875) and Art. 43 sec. 6 of the Act of 21 December 2000 on inland navigation (Dz. U. /Journal Of Laws/ of 2019, item 1568, 1901, 2170, and of 2020, item 284.),

The State Water Holding Polish Waters – Regional Water Management Board in Wrocław would like to announce that as of 6 September 2021, at 12:00 a.m. the Downtown Water Junction in Wrocław is open for navigation from Piaskowy Bridge and Tumski Bridge up to the exit from the lower canal of Mieszcząńska Lock, with the transit depth of 100 cm.

Navigation at night is prohibited on the indicated section.

Conditions for water navigation at Mieszcząńska sluice

Maximum parameters of vessels:

length L = 24.00 m, width B = 4.80 m, draught T = 0,70 m.

Hours of operation: Mondays 6:30 a.m. - 2:00 p.m.; other weekdays and holidays 6:30 a.m. - 9:30 p.m.

Communication with the gate operator: channel 74 VHF or phone number: 502 331 251

Mooring to the shore of the channel is prohibited.

The crews of all vessels passing through the sluice are required to exercise extreme caution, strictly observe the displayed navigation signs and instructions of the gate operator.

Traffic organisation on the Downtown Water Junction

- One-way traffic, downstream, under Maciej Bridge (no upstream navigation)
- One-way traffic, upstream, in the section from Klara Inlet to Młyński Bridge (no downstream navigation)
- Generation of water waves and navigation of non-mechanically propelled units is prohibited throughout the whole Downtown Water Junction.

Notice to Skippers No. 54/2021 is repealed.
