NOTICE TO SKIPPERS No. 22/2022

Subject: Rebuilding of a road bridge in Krosno Odrzańskie at km 514.1 of the Oder River change in communication rules

Pursuant to Art. 14 sec. 1(4) of the Act of 20 July 2017 – Water Law (Dz. U. /Journal of Laws/ of 2021, item 2233) and Art. 43 sec. 6 of the Act of 21 December 2000 on Inland Navigation (Dz. U. /Journal Of Laws/ of 2020, item 1863).

The "Polish Waters" State Water Holding – Regional Water Management Board in Wrocław hereby informs that in connection with the renovation of the road bridge in Krosno Odrzańskie km 514.1 of the Oder River, temporary supports will be installed narrowing the width of the existing navigation span to 25 m. Construction of the supports will be carried out upstream by hydrotechnical units, which will also be involved in the renovation of the crossing.

Due to the ongoing work, **from 31 May 2022 until further notice**, all vessels wishing to pass through the designated area are required to notify, 4 hours before the passage, **the construction manager (phone No. 609-116-933)** or the site manager (**phone No. 781-820-526**), or possibly floating equipment operators (**phone No. 601-718-936; 605-422-630**), to allow equipment to be moved out of the navigation route. Two kilometres before the bridge, the shipmaster must obtain confirmation that the waterway is passable and safe. In the absence of such confirmation, please refrain from further navigation and notify the construction works manager (phone: **609-116-933**) and the **"Polish Waters" State Water Holding (phone: 601-269-499 or 605-631-972)**.

A separate notice to skippers will be issued in the event of a complete closure of navigation in the section affected by the works.

Passage through the indicated section is permitted only during daylight hours under conditions of good visibility.

The crews of all vessels passing through this section are requested to exercise particular caution, follow the above procedures and displayed markings.

Information on the completion of the works and the return to normal navigational conditions will be given in a separate notice to skippers.

Notice to Skippers No. 18/2022 is repealed.
