NOTICE TO SKIPPERS No. 44/2022

Re.: demolition works, support of the temporary road bridge in Ścinawa at km 331.90 of the Oder river - restoration of the original height parameters of the crossing

Pursuant to Art. 14 sec. 1 point 4 of the Act of 20 July 2017 – Water Law (Dz. U. /Journal of Laws/ of 2021, item 2233) and Art. 43 sec. 6 of the Act of 21 December 2000 on Inland Navigation (Dz. U. /Journal of Laws/ of 2020, item 1863).

"Polish Waters" State Water Holding Regional Water Management Board in Wrocław informs that in connection with the renovation of the road bridge in Ścinawa, the supports of the temporary bridge, approximately 23 m above the existing crossing, will now be dismantled. The dismantling of the temporary bridge supports will be carried out in the riverbed by water engineering units. Due to the performed works, **from 24 October 2022 until 10 November 2022**, all vessels wishing to pass through the designated area are required to notify the unit in charge of the works, Fabico 5 (tel.: 504 292 025; channel 10 VHF), or the construction site manager (tel.: 661 334 006 or 603 882 528) 4 hours prior to the arrival, so that the equipment can be removed from the navigation waterway. Two kilometres before the bridge, the unit leader must obtain confirmation that the waterway is passable. In the absence of such confirmation, please refrain from further journey until such information is obtained and please notify the construction site management (tel.: 603 882 528 or 661 334 006) and ZPH Chobienia (tel.: 609 222 442) about the situation.

Passage through the indicated section is permitted only during daylight hours under conditions of good visibility.

The crews of all vessels passing through this section are requested to exercise particular caution, follow the above procedures and displayed markings.
